SPEAKER: Attorney Amir A. Ladan, who is a candidate for Seminole County Court, Group 5, will discuss the basics of handling the various types of criminal law cases from the intake process to final disposition.

Attorney Amir A. Ladan, a resident of the Central Florida area since 1984, graduated from Rollins with a B.A. in Politics & was named an Algernon Sydney Sullivan Scholar. In December 1997, Amir graduated from the University of Miami School of Law, having earned his Juris Doctor in only two and a half years. He was admitted to the Florida Bar in April of 1998 and in May of '98 accepted an offer to work as an Assistant State Attorney for Lawson Lamar, State Attorney for the Ninth Judicial Circuit (Orange & Osceola Counties). Mr. Ladan worked at the State Attorney's Office and while at the State, he prosecuted thousands of cases ranging in severity from low level misdemeanor offenses to life felonies in both adult and juvenile court. In 2001, after three years as an Assistant State Attorney, Amir co-founded Carsten & Ladan, P.A. with his trial partner, Keith A. Carsten. Since that time he has developed a successful and well respected law practice. Currently, Mr. Ladan is a candidate for a judicial seat with the Seminole County Courts, Group 5.
